This IDA neutralization @73.8% on the basic pay is in lieu of IDA neutralization @68.8% on the basic pay as mentioned in para 2.2.21 of the above letter no MTNL/CO/IRW/22(90)/07/NE/260 & MTNL/CO/IRW/22(90)/07/Exec/261 dated 14.05.2010.

No arrears will be paid and the revised fitment on the basis of DPE O.M. dated 02.04.2009 will be paid with effect from 01.01.2018.

The payment of HRA, perks and allowances based on the revised basic pay will be from the date of issue of this order in accordance with para 2 (v) of DPE, O.M. dated 02.04.2009.

All other terms & conditions of MTNL Office Order(s) dated 14.05.2010 referred above shall remain unchanged.
