- 2. This Promotion Order is issued after obtaining the Vigilance Cicarance from the Vigilance Branch of MTNL Delhi and is further subject to the following conditions.
 - a. The Officer(s) have been permanently absorbed in MTNL

 - c. Currency of penalty, if any, against the Officer(s) is over.
- 3. The promotion shall be effected notionally w.e.t the date shown against each. However actual financial benefits may be accorded with effect from the date the officers assume charge in the grade of Dy Manager(Telecom)/SDE(Telecom). The promoted officers, if already
