

Reference is invited to this department's letter No.6-23(1)/2010-PAT dated 17.2.2012 vide which it was conveyed that those Group 'A' officers who are on deemed deputation to BSNL may be allowed the payment of allowances as per 6th CPC, however, they may not be allowed to draw the allowances being paid by BSNL which are not admissible to Central Government employees as they can not be allowed to claim both the benefits. Several representations have been received from officers in MTNL for extending the aforesaid provision also to the employees working on deemed deputation in MTNL.

The matter has been examined in this department and it has been decided that those Group 'A' officers who are on deemed deputation to M'I'NL may be allowed the payment of allowances as per 6th CPC, however, they may not be allowed to draw the allowances being paid by M'I'NL which are not admissible to Central Government employees as they can not be allowed to claim both the benefits.
