CIRCULAR

Sub: Renewal of Group Health Insurance Scheme for MTNL Working Employees w.e.f 14.06.2020.

MTNL Management had offered GHIS for MTNL working employees w.e.f 14.06.2019 for a period of two years on Tender terms and conditions to M/s UIIC Ltd. The Policy for the period 14.06.2019 to 13.06.2020 is expiring on 13.06.2020 midnight. As per the approval of Competent Authority, the said policy has been renewed with M/s UIIC Ltd for one year for the period 14.06.2020 to 13.06.2021 as per existing terms and conditions and same premium. The renewal of the scheme will take effect from 14.06.2020 for one year. The annual premium for the period 14.06.2020 to 13.06.2021 has been released to M/s UIIC Ltd.

Accordingly the Indoor part of the Scheme will continue to be served by M/s UIIC Ltd through the existing TPAs in Delhi & Mumbai Unit. **The details of TPAs and Helpline No/ Nodal Office etc from M/s UIIC Ltd will remain the same as per this office letter No MTNL/CO/Pers/Medical/Renewal/19-20/ dated 13.06.2019.**

The Primary Agreement, Tailormade Health Insurance Policy, MTNL Working Employees Group Health Insurance Scheme, already signed between MTNL & M/s UIIC Ltd, and Tripartite Agreement already signed between MTNL, M/s UIIC Ltd and all TPAs will be valid for the period 14.06.2020 to 13.06.2021 also.

Further it is also intimated that existing I.D Card/ Indoor Medical Card will be valid in all existing hospitals. The employees data as received from FMS has been provided to M/s UIIC Ltd.

Other terms and conditions of our circular No MTNL/CO/Pers/Medical/Tendering/Renewal/19-20/ dated 13.06.2019 will remain the same.

Any other information in this regard may be had from the concerned GM(Admn) office in Delhi & Mumbai/PGM(HR) in CO or from the day time Help Desks provided by the TPAs for the benefit of the employees.
