Protest Notice Seeking Permanent and Safe Future for MTNL Employees

During the Transition of MTNL Services to BSNL.

#### Respected Sir,

We are constrained to submit this protest notice on behalf of the Forum of MTNL Unions and Associations to draw your urgent attention to the growing unrest and anguish among MTNL employees in light of the ongoing transition of services, operations, and customers from MTNL to BSNL.

Despite the fact that most of MTNL's services and customers have already been migrated to BSNL and the process is nearing completion, no tangible action has been taken to decide the permanent fate of MTNL employees. These very employees are continuing to work diligently and responsibly to support the government's vision and ensure a smooth migration—even though their own future remains uncertain.

We are not here to oppose the policies of the Government regarding the revival of BSNL and transition of MTNL services. On the contrary, MTNL employees have stood firmly with the Government's vision led by Hon'ble Prime Minister, and have committed to being partners in this nation-building initiative. However, it is deeply painful and demoralizing that even as services are being moved, employees are being left behind in an empty shell— MTNL—a company that soon will have no services, no revenue, only assets and loan liabilities.

To make matters worse, HR benefits have been stopped, and no roadmap has been provided to employees who have served the telecom sector with dedication for decades. In such a scenario, it is becoming impossible to keep the morale of the employees intact. The current state is one of disillusionment and helplessness, and a strong sense of betrayal is spreading among employees, who fear being left without job security, benefits, or a dignified future.

We believe this is not just an administrative lapse but a matter of human justice. Our repeated appeals through letters and meetings with MTNL management, DoT officials, and even with the Hon'ble Minister of Communications have so far yielded no substantive solution. Therefore, we are now compelled to initiate peaceful and democratic protest actions to seek justice and demand a clear, permanent, and safe future for all MTNL employees.

- 3. To conduct JNC Meeting immediately and resolve all HR related issues submitted in JNC Agenda.
