**Subject:** Redeployment of DoT recruited MTNL absorbed officials in the other department/PSU/Institutions across the country.

Sir

In reference of above subject of corporate office letter No. MTNLCO/Pers/Circulation cases file/2017/1556 dated 22-05-2018, we express our resentment on the issuance of this order, because before taking such an important decision related to the Officers, representatives were not taken into confidence to place their views on this matter which is related to the service carrier of officers. Therefore, this matter should be discussed with the Association before concluding this matter in any form.

There is no clarity on objective and motive of this order also and there are no details how this process will be executed. This type of open ended order is creating negativity and uncertainty in the minds of the executives, which in turn will have unnecessary negative effect on the moral of the executives in this crucial time when company is striving hard for revival.

We are astonished to see that MTNL management itself has created the dividing line between the DOT recruited absorbed employees and MTNL recruited employees, which is neither fair nor in the interest of the company. If at all such options have been called for and an opportunity is being given to serve in another PSU/ Govt department, than it should have been for all irrespective of DOT recruited or MTNL recruited officers. This discrimination has once again created lot of anguish in the MTNL recruited officers. **Therefore, we request MTNL management not to discriminate in the name of DoT recruited and MTNL recruited executives for deputation/redeployment.**

**So, in view of above, we request MTNL management to have a discussion with the Association to make the things clear before taking any final decision in this matter.**
