Sub: Revision of CDA Pay Scales for the Staff belonging to the Organized Accounts Services in Central Government.


Reference is invited to this Office Memorandum of even No. dated 03.11.2008 on the above mentioned subject wherein re-implementation of Government of India (MOF) O.M. No. F.6/82.E.III (B)/91 dated 28.02.2003 in respect of the employees of erstwhile Organized Accounts Services absorbed in MTNL, was conveyed. Consequently, references received from the Units with regard to regulation of their pay in their respective post-absorption period, has been considered. Accordingly, the following procedure is conveyed with regard to their pay fixation in the post-absorption period.

This issues with the approval of the Competent Authority.




