APPEAL

This is in reference to Notice MS-54/Forum/2019/47 dtd. 25.07.2019 served by Forum of MTNL unions and associations regarding Relay Hunger Strike at MTNL, CO and O/o Executive Director, MTNL, Mumbai from 20th Aug. to 24th Aug. 2019.

MTNL is going through extreme financial crisis. The payment of salary to MTNL employees is being delayed in the last few months due to funds shortage due to mismatch in revenue inflows and liability outflows. MTNL is meeting its liability till now through mix of revenue earning and borrowings. At present the borrowing has become very difficult due to stress in telecom sector.

The salary of June 2019 has already been paid and efforts are being made to release the salary for the month of July 2019.

Further, to ensure regular payment of salary on due date of every month MTNL management is making all out effort for revival of MTNL. Lots of engagements are going on with DoT on the matter. At this stage any agitation programme will adversely impact the revival efforts of MTNL.

Your kind attention is also drawn to the fact that such Trade Union action causes serious dislocation of services lowering the image of MTNL and our valuable customers are unnecessarily made to suffer.

Further it is kindly requested to abide by the interim directions dtd. 12.09.2017 given by the Hon'ble HC in Civil Suit (OS) 437/2017 which restrains holding of demonstrations, Dharna, meeting in and around 100 meters of MTNL registered office CGO complex and MTNL office Khurshid Lal Bhawan and all other offices of MTNL situated at various places in Delhi and/or blocking/ obstructing the ingress/ egress of the officials of the MTNL, its visitors and employees.

In view of the above, you are requested to advise the representatives of the forum not to proceed on the said Relay Hunger Strike considering the cut throat competition, financial position of the company and the fact that such protest action will bring bad name to the organization and cause inconvenience to our Valued Customers.
