Subject: Regarding extension of last date for applying CGHS reimbursement, opting for CGHS Scheme

Sir,

MTNL Corporate office was kind enough to consider the CGHS scheme optional for one year and extended the last date upto 31-12-2017 for applying CGHS medical scheme and payment for CGHS reimbursement. But the present status of MTNL Mumbai is that more than 2000 PPOs are still have to be delivered to the pensioners and PPOs of more than 300 pensioners are yet to be prepared. Some cases are also pending for preparation of PPOs in MTNL Delhi.

We earnestly request your good self to consider following justified issues:

1. To make the CGHS medical scheme optional without last date.
2. To extend the benefit of CGHS reimbursement to the last retired combined optee of MTNL, who opts for CGHS medical scheme.
3. To make 100% CGHS reimbursement.
4. Current retirees should be given 3 months period to switch over to CGHS/CGHS medical scheme after delivering of the PPO book to the pensioner.
5. During the intervening period, retiree should be given OPD/IPD medical facility of MTNL.
6. To keep last date for CGHS/CGHS scheme open ended till the last combined optee of MTNL is retired because they should not be deprived of these facilities.

BSNL has already approved the above said points long back. MTNL is heavily off leaded by implementing the decisions of Govt. pension & CGHS medical scheme. So, in the light of above facts, we request your good self to consider the genuine & justified demands of the pensioners favorably.
