The MTNL Board in its 236<sup>th</sup> meeting held on 4-7-2008 decided to re-designate Executive posts in MTNL as below, which were circulated vide CO office No-MTNL/CO/Pers/2008/428,

September 8, 2008.

A change in designation shall be effected only on promotion to the substantive grade. The position of Manager in E4 grade corresponding to Sr SDE/ Sr AO etc, shall be on personal basis.

As per these orders and new designation hierarchy, officers in substantive post of Deputy Manager in E4 and above grade are to be given personal designation as Manager like SDE/AO were given Sr SDE/ Sr AO in their lateral advancement of scale in old designations of DOT promotion streams.

But, personal designation of Manager to the above mentioned officers is not being given in MTNL and even the officers who are in E5/E6 grade working as Senior Manager on looking after basis for so many years are retired as Dy Manager. This personal Designation of Manager is with the same financial and administrative powers of Dy Manager, so has no implication of any

kind, but just a motivation to the officers. Even MTNL is giving these personal designations in Sr Management promotion policy as Jt GM and Addl GM.

Therefore, I request your good self to issue the direction to the concerned officers of CD/Delhi/Mumbai Unit to implement above orders in true spirit and extend this personal Designation of Manager to the officers in substantive post of Dy Manager in the grade of E& and above and retire them with their personal designation. ## Sub: Designation of Executives in MTNL

The MTNL Board in its 236" meeting held on 4.7.2008 decided to re-designate Executive posts in MTNL. In this regard, it has been decided to rationalize the designations of Executives in the grades E1 to E5, i.e., from scale of pay of Rs. 8600–260-14600 to Rs. 16000-400-20800. The standardized designations corresponding to the substantive posts in various grades shall be as per details given below.

The functional discipline of the position shall be suffixed (\*) to the aforesald standardized designation.

A change in designation shall be effected only on promotion to the substantive grade. The financial upgradation granted under the Time Bound scale upgradation policy shall not automatically bestow benefits associated with substantive posts. The position of 'Manager' in E4 grade corresponding to Sr.SDE / Sr.AO etc., shall be on personal basis.

This shall come into force with immediate effect. Units may accordingly take further action.
