Subject: Messy and unsystematic withholding of promotion order to the posts of Executive Engineers (Civil).

Sir,

This is in continuation to our letter no. MEA/CHQ/DM/CMD, dt 15.05.2013 and pursuance thereafter highlighting the urgent need of filling all vacant posts in Executive Engineer (Civil) cadres on regular basis. The sanctioned posts of Executive Engineers (Civil) in MTNL had been 32 with equal number in Delhi and Mumbai. This has been unreasonably and arbitrarily reduced to 21, vide MTNL CO letter no. MTNL/CO/R&E/2009, dt 30.06.2012. Even most of these posts are lying unfilled as on date. Only one post is filled up, who is also due to retire in next 7 months.

The DPC in overdue promotion case of EE(C), DPC has been held in Sept 2014 but issue promotion orders are held up excessively in Corporate Office for frivolous, superfluous and redundant reasons. This has been causing great heart burn to the empanelled executives already working in LA for last 8 year.

It is a harsh fact (or tactical motive) in MTNL, that whenever executive promotions are made; they are done so at verge of one's retirement, frustrating the purpose and leaving no one left for succession to higher post. To look after the maintenance of vast pool of buildings and real assets, sufficient and large numbers of Executive Engineers are inevitable. It has already affected adversely the construction and maintenance activities and all projects have suffered huge time over runs for lack of Executive Engineer and Maintenance requirement of buildings have aggravated.

It is worth noting that Real Estates and Buildings are the main asset of MTNL, which gives strength and competitive edge to the company in today's difficult time, the capital value of which is more than 20,000 Crore. We are also pushing on monetising real estates and earning revenue by renting.
