Sir,

This is to bring into your kind notice that One of the brightest officer of MTNL Delhi Sh Manish Kumar, AM(T), posted under GM (North) Delhi, who pioneered the revolutionary exchange management system suffered a severe accident while performing his official duties on 19.04.2018. The accident proved fatal and led to untimely demise of the brilliant officer. The officer has always been praised for his out of turn commitment towards his duties. In his previous assignment in CETTM Mumbai, his contribution was appreciated on record by a concerned PGM.

His sudden demise has sent a severe shock wave across all cadres leaving very serious and significant questions on the face hardworking Direct Recruittees, who are now feeling insecure and helpless because they are at peril of their own as far as social security of their families & work environment are concerned.

In this regard, your immediate intervention and action is required, for following two types of measures:-

1. IMMEDIATE MEASURES

- Appointment to His Wife at least at E-2 level as a special case.
- One time Ex-gratia Compensation of Rs.1 crore apart from his official dues.
- Continuation of ongoing accommodation for his family on rent free basis till appointment of his wife.
- Independent Inquiry of the Incident and disciplinary action against the guilty.

2. URGENT MEASURES FOR RECRUTEES OF MTNL


- 30% corpus benefits in line with BSNL for Recruittees of MTNL.
