Sir,

With reference to the aforesaid I am inviting your kind attention to the above compliance affidavit filed by the aforesaid Controller of Communication Accounts of the department of telecommunication Govt of India which inter alia states as under:

- 1. At the outset, I unconditionally apologise for the delay in compliance with the order dated 7th November, 20 17.
- "2. The order 07th November, 2017 has now been complied with. The decision has been taken by the Government on the proposal of MTNL. The decision has been communicated to the advocate for the plaintiff as well as to the Plaintiff. The same was communicated to the Plaintiff by the letter dated 8th February 2018. The delay in compliance has been on account of the procedure to be followed in the decision making process.. Here annexed and marked Exhibit "A" is a copy of the communication dated 8th February 2018. "
- "3. By an order dated 6th February 2018, this Hon'ble Court has taken note of the non compliance of the order dated 7th November 2017. This Hon'ble court has directed Secretary, Department of Telecommunication to remain present before this Hon'ble Court. It is humbly prayed that the Order dated 7th November 2017 has been complied with. Hence the presence of the Secretary, department of Telecommunication on 12th February may be dispensed."
- 4. in view of the aforesaid compliance affidavit of the Union of India Defendant No.5 in the said suit pending on the Hon'ble High Court may be hereby requested to kindly notify to all the MTNL employees of the Schedule of disbursement of the arrears along with dues of the current financial year which is accrued since 01/01/2007 to all the employees of the MTNL of 78.2% DA merger / neutralisation amounting to Rs 1166.28 Crs total arrears w.e.f. 1.1.2007 to 31.3.2017 amount in the case of implementation of IDA neutralisation at 78.2% and yearly financial dues on recurring basis on each year of 78.2% IDA neutralisation amounting to Rs 174.25 Crs including the current financial year dues admitted by MTNL in their affidavit dated 12/02/2018 filed in the Hon'ble Bombay High Court,

Kindly do the needful at the earliest and oblige.
