Your good self is reminded that listed issues have been raised by the unions/associations time and again with comprehensive notes on each subject but every time issues have been relegated to back drop for one or the other reason nearly for a decade. As such, non-implementation of the agreements tantamount to breach of trust.

Where as, MTNL management is **defaulter of breach of trust** in circumvention to proviso to I.D. Act 1947.

Now, Therefore, Forum of MTNL unions and Associations resolves to declare following **Industrial Action Programme** provided that negotiations are not resumed to arrive at an amicable settlement at par excellence with BSNL.
