Subject: Regarding inordinate delay in the payment of pensionary benefits to the retirees w.e.f January 2014 onwards & payment of pension to the retirees w.e.f April 2014 onward.

Sir

You are well aware of the plight of the retired employees of MTNL who have shed their sweat and blood for this company while serving for more than 35/40 years, are now running from pillar to post for their payments, and situation is that many of retired employees have not received single paisa after their retirement, and are struggling to meet the end to feed their families. This burning issue has been discussed many a time with your good self and senior officers in DOT, but still no relief has been given to them and situation has further become painful with the indication of MTNL management not to pay pension for the month of July 14.

Your good self is well aware of the following facts-

- 1. Payment of Leave encashment & commutation is pending for the employees retired w.e.f January 2014.
- 2. Payment of DCRG, leave encashment & commutation is pending for the employees retired w.e.f March 2014 onwards.
- 3. Payment of pension has not yet been started till date to the retirees, retired w.e.f April 2014.
- Payment of arrears of revision of pension is pending who retired before January 2007 including the VRS optees.

In view of above mentioned worst situation, this Association requests your good self to take immediate necessary action to make the payment of terminal benefits to the retired employees and also timely payment of pension of July 2014. In case of further delay in settlement of above issues, we will have to
