Respected Madam/Sir,

It is in continuation of various notices served by this forum, meetings and appeals by MTNL Management, and our last meeting with MTNL management on 26-12-2016 after our strike notice dated 03-12-2016 in which CMD, MTNL had assured that issues raised by Forum will be taken up in the DOT and resolved shortly. After appeal of CMD MTNL vide letter No-MTNL/CO/KW/21(135)/ 2016 dated 26-12-2016, this forum deferred the strike for two months with the hope that MTNL management will honour the assurance in true spirit and settle the issues harmoniously. But to our amazement, MTNL management did not make any effort to settle the issues, may be our cooperation and concern to run the company smoothly has been taken as our weakness. In spite of our repeated request to discuss & settle the issues, management turned deaf ears on the issues and requests made by the forum.

Now, we are forced to resume our deferred protest action, followed by strike against abnormal delay in settlement of the attached issues raised by forum.
