Dear Sir,

With reference to ED , Delhi Letter No. Bldg(II) /One Step Higher/type V / 2016 Dated at ND 17-9-2016 & Corrigendum of this letter on the subject -" Regarding allotment of Tentative vacant Type V quarters in MTNL" it was intimated that approximately 30 quarters of Type V are vacant due to no demand of these quarters and so it was proposed to allot these quarters to Executives entitled for type IV quarters who are:-

- (a) Already in occupation of type IV quarters,
- (b) Interested in type V accommodation but have not yet applied,
- (c) In occupation of type IV quarter but have applied for a change &
- (d) In waiting list (change / seniority) for type IV quarter.

The allotment letters in this regards have been issued mentioning License Fees @three times of normal charges. This is injustice for MTNL Quarter occupants who are of the level of E-5 & E-6 grade officers as they are already financially burdened compulsory deduction of "FRINGE BENEFIT TAX" also. It is pertinent to mention here that the charging of three times of the normal fees was never mentioned in Letter No. Bldg(II) /One Step Higher/type V / 2016 Dated at ND 17-9-2016 & its subsequent Corrigendum of this letter on the subject -" Regarding allotment of Tentative vacant Type V quarters in MTNL".

For the optimum utilization of the vacant quarters, the relaxation may kindly be granted in license fees for this kind of up-gradation of quarter since in this case MTNL itself proposed to allot quarters by asking them to apply. Accordingly REVISED allotment letters may kindly be issued after due consideration of License fees at NORMAL RATE only.
