Sub: Withdrawal of Vehicles due to financial constraint - Regarding

Sir

This is with reference to C.O. letter No. MTNL/CO/Admn./Hiring of Vehicle/2019-19 dated 24.06.2019. It is mentioned in the C.O. Letter that for operational and maintenance work some vehicles (not more than 201% of the sanctioned vehicles) may be kept in office in general pool. In this regard, I wish to submit that this proposal will invoke some practical problem like- vehicle required by more than one unit at the same time and priority of work advocated by each unit. So in this situation, this pooled vehicle will become a bone of contention.

In view of above, it is submitted that a more viable solution in such a situation would be to allow every DGM unit under GM to hire vehicles from OLA/UBER on need basis.

The amount may be fixed and divided amongst each DGM Unit equally by taking into consideration the total amount to be paid to the hired vehicle of the pool. This amount so fixed will be used jufficiously by each DGM Unit for their needs preferably for operation and maintenance purpose. This will also help all the Units to use the vehicle for their work simultaneously at the same time.

It is also understood that use of OLA/UBER has been allowed in BSNL. Therefore, if this is also permitted in MTNL, there will be some relief to the officers of different units, and check on financial aspect will also be adhered to as desired by C.O. The OLA/UBER bills are transparent and can be produced for submission for records of A/Cs.

It therefore, request your good self to consider this proposal in the wider interest of MTNL Services. With Regards
